Every dollar in final sales of manufactured products supports \$1.40 in output from other sectors of the economy and manufacturing represents 12 percent of our gross domestic product. One in six private sector jobs is in or directly tied to manufacturing.

In addition, manufacturing drives innovation and technology which is essential to economic success. Manufacturers are responsible for more than 70 percent of all private sector R&D, which ultimately benefits other manufacturing and non-manufacturing activities. Two-thirds of our nation's total exports of goods and services are related to the manufacturing sector.

You may nominate your company or other AWB members for consideration. Information submitted will remain proprietary for use only by the awards evaluation committee and returned upon written request.

AWARD CATEGORIES

Awards will be presented to a small manufacturer (1-99 employees) a medium manufacturer (100 - 499 employees) and a large manufacturer (500+ employees) in the following categories:

- Green Manufacturing
- Innovation
- Operational Excellence
- Manufacturer of the Year

The evaluation committee has the authority to withhold an award in any category if it is deemed a suitable entry does not exist.

SUBMISSION GUIDELINES/CRITERIA

All AWB members are eligible (non-members are ineligible). Judges will determine winners based on the content and quality of the nomination materials. Particular attention will be given to economic impact, product and quality innovation and improvement, corporate responsibility and workforce excellence.

AWARDS PRESENTATION

Representatives from each award-winning company will be honored at a special luncheon held in conjunction with AWB's Annual Policy Summit on Sept. 22, 2010. Awards will be presented to award winners and press releases with photos will be sent to news media statewide.
